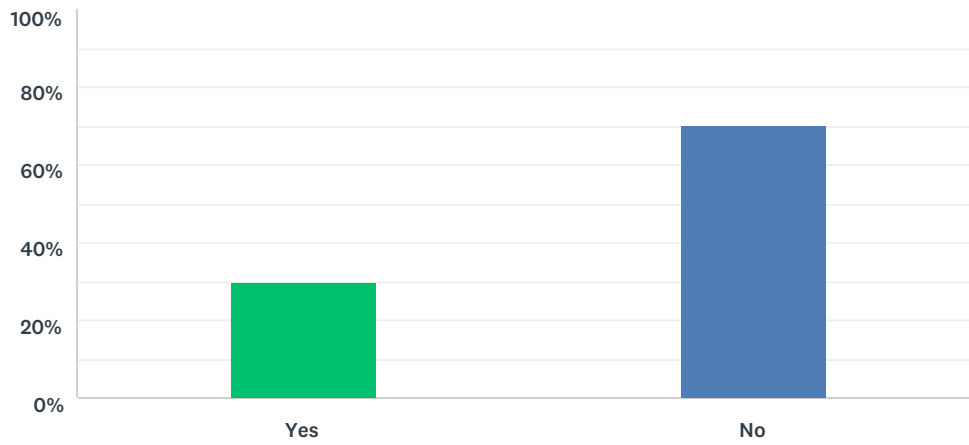


## Q1 Do you live in the Oban area?

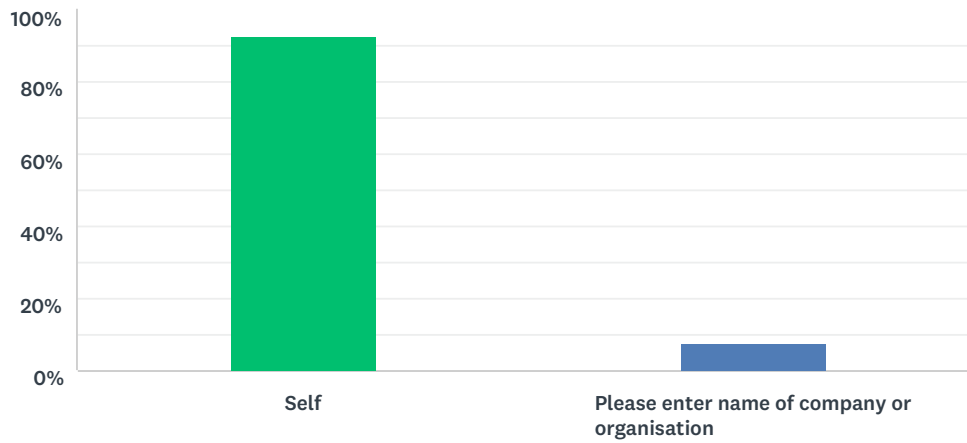

## Q2 Are you representing yourself, or, a company or organisation?

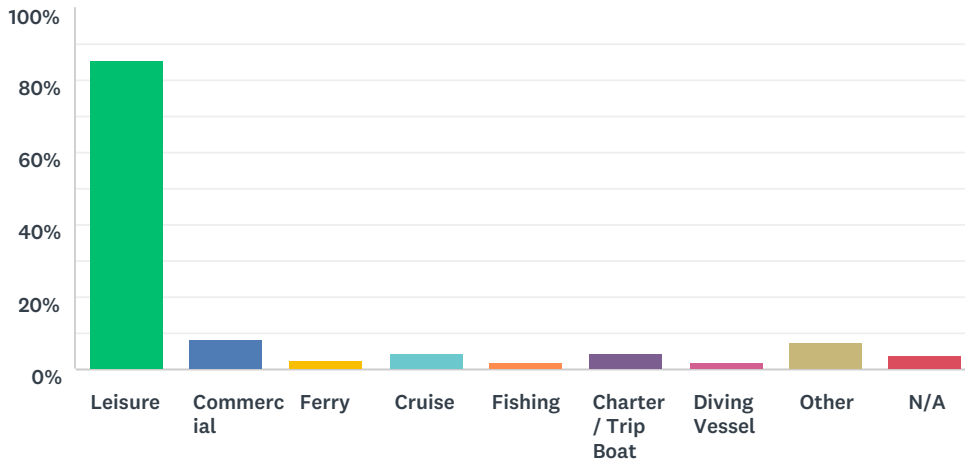

### Q3 Which type of vessel or business do you operate or represent? Please tick all that apply.

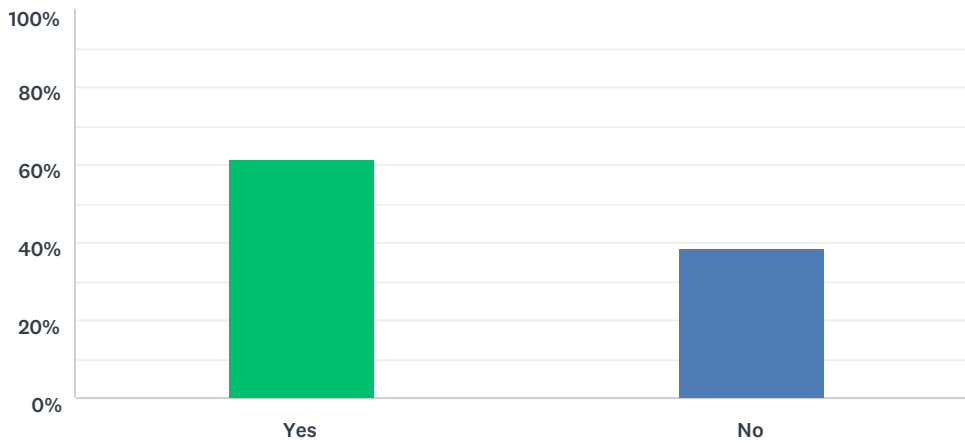

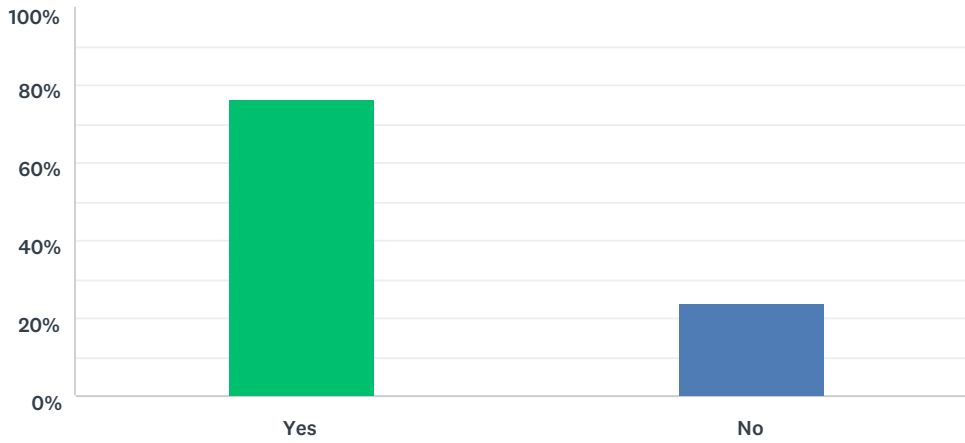

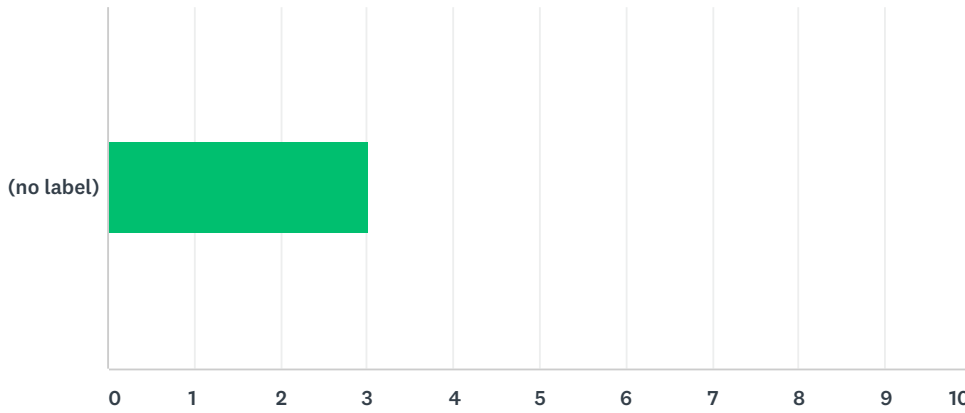

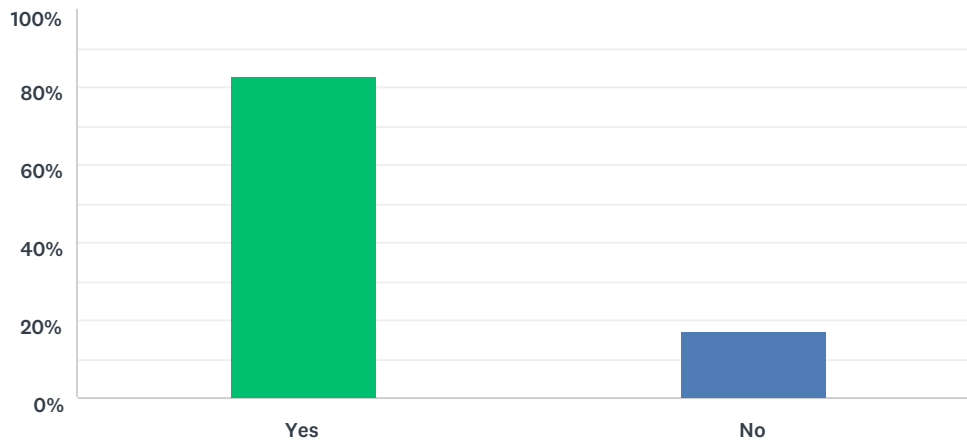

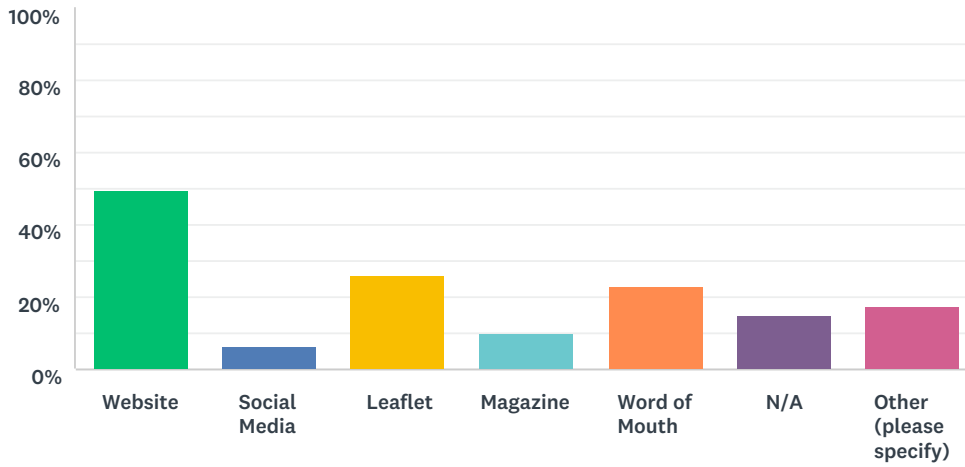

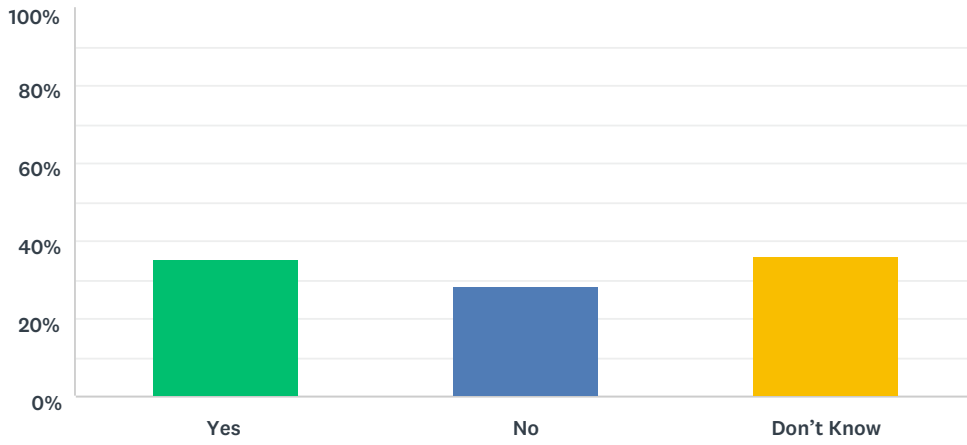

## Q9 Will a statutory harbour authority for Oban Bay be beneficial to navigational safety

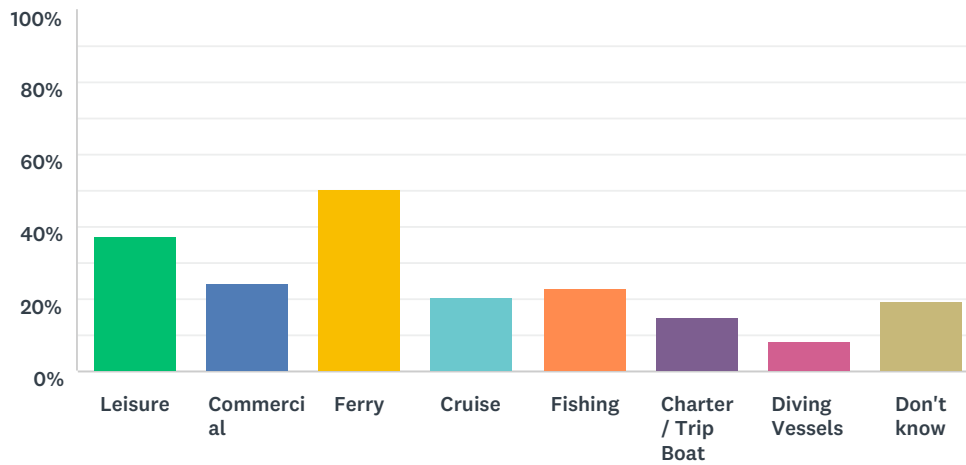

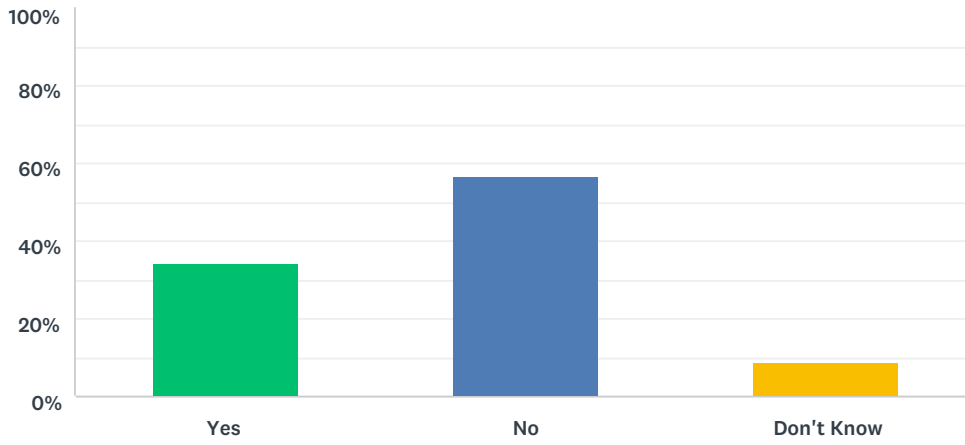

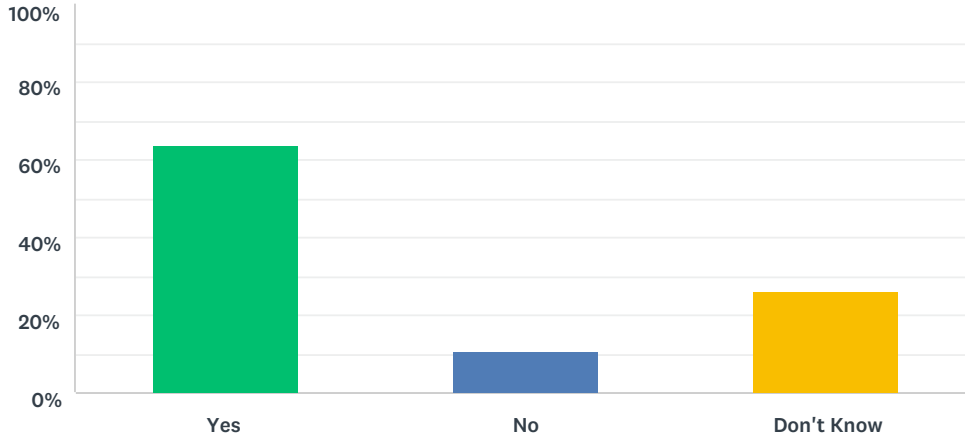

**Q12 If a wider harbour authority passes the costs for running a harbour at Oban onto all marine users, will this affect the commercial viability of marine businesses at Oban?**

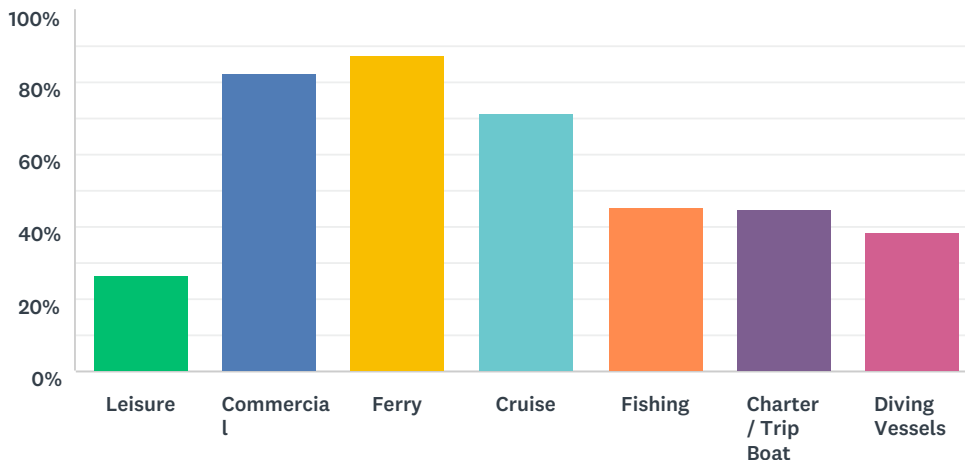

**Q13 Which type of users should a wider harbour authority pass its running costs onto at Oban? Please tick all that apply.**

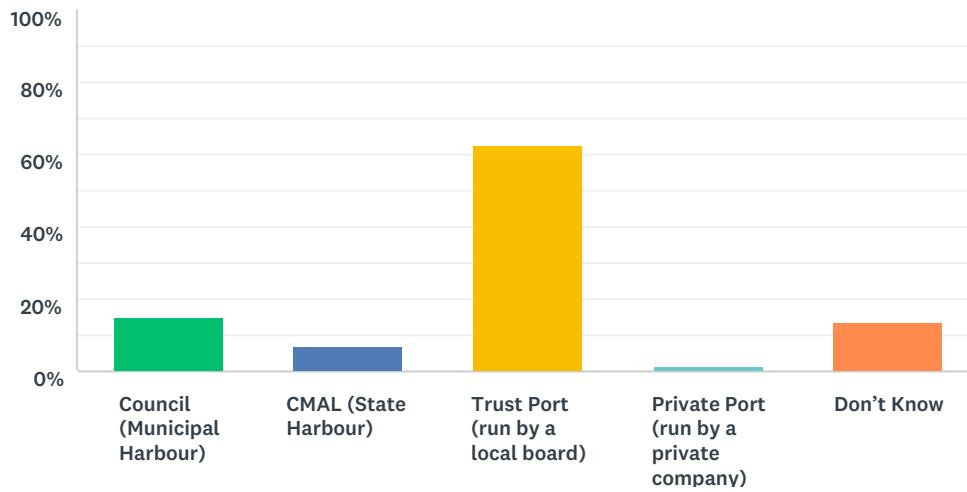

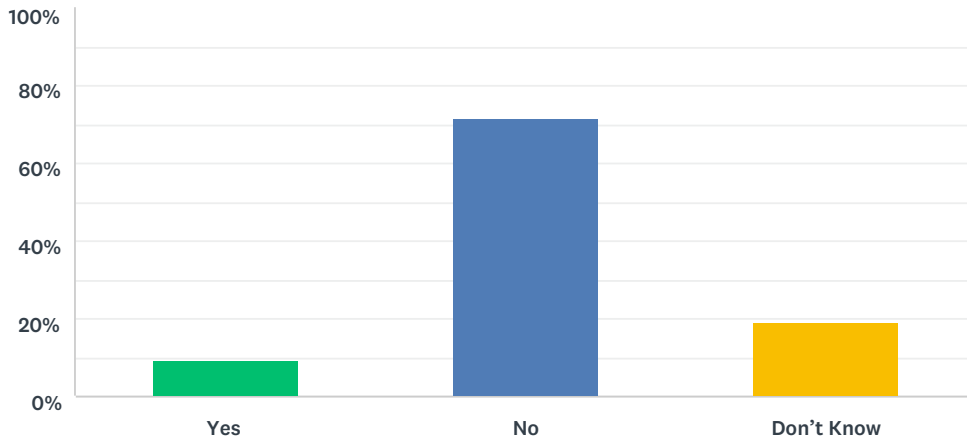
